

#### Introduction

Thessalonica was a good-sized city of approximately 200,000 people. It was primarily a commercial city, its location being its greatest asset. Thessalonica was on the northwest shore of the Aegean Sea and just east of the Auxius River. It was also located on the famous Egnatian Way - the main road From Rome to the East. Being a port city on the Egnatian Way made Thessalonica an ideal city for merchants to sell and For the general population to easily reach. Thessalonica was also the capital city of the province of Macedonia. Since 146 B.C., it had been the seat of Roman government for Macedonia.

The church in Thessalonica was founded on Paul's second missionary journey (Read Acts 17:1-9 For the background to this event.) Later, Paul could write to them, saying; "And we also thank god continually because, when you received the word of God, which you heard from us, you accepted it not as the word of men, but as it actually is, the word of God, which is at work in you who believe." (1 Thessalonians 2:13)

As a result, in receiving the word of God as it actually is "the Lord's message rang out from you not only in Macedonia and Achaia - your faith in God has become known everywhere. Therefore we do not need to say anything about it, for they themselves report what kind of reception you gave us. They tell how you turned to God from idols to serve the living and true God, and to wait for His Son from heaven, whom He raised from the dead - Jesus, who rescues us from the coming wrath." [1 Thessalonians 1:8-10)

Both 1st and 2nd Thessalonians have much to say about the end times. This is called eschatology. Concerning eschatology, the New Bible Dictionary states, "Biblical eschatology is concerned not only with the destiny of the individual but also with history. This is due to the particular character of biblical revelation. God does not only reveal Himself by means of inspired men, but also in and through

the events of redemptive history, the most important of which are the advent and life of His Son, Jesus Christ. Furthermore, the content of this revelation is not limited to truths about the character and purposes of God, but includes also His redemptive acts in history, and the inspired Word of God which interprets the meaning of these acts. Since God is the Lord of history, the consummation of God's redemptive work will include the redemption of history itself."

Timothy, having been sent by Paul to Thessalonica, returns to him in Corinth with a report regarding "the situation at Thessalonica." Paul writes to them in about the spring of 50 A.D., and he addresses them about:

- 1) The healthy spiritual condition of the church [1:1-10).
- 2) False rumours to discredit his ministry and message (2:1-16).
- 3) His longing to see them again (2:17-3:13).
- 4) Living to please God (4:1-12).
- 5) The coming of the Lord (4:13-5:11).
- 6) Some Further instructions (5:12-28).

As you study these letters and put into practise their instruction, you will contribute to our assembly's reputation as a church where people live *lives "worthy of God, who calls us into His kingdom.*"

### **Bible Study Format**

#### I . UNDERSTANDING WITH APPLICATION

This study is similar, and yet different than many of the home bible study's that we have conducted over the past several years. You will perhaps notice this difference from the Study and Response format developed over the years. The similarity is that, as you go through the study, you will still work to know the meaning of the text as well as responding to it in a practical way. The difference is that each of you who participate in the Bible Study will be called upon to consider practising the truths of each question as you work at understanding its meaning. Thus, a link is formed in each question between understanding and applying Bible truths.

#### II. GROUP DISCUSSION

In this section the Bible Study groups will be called upon to deal with a specific truth or practise in each study of the book under consideration. In working with these Bible truths, all members of each Study are encouraged and will be called upon to share their answers as well as discuss the topic.

The objectives of this group discussion are:

- a) To spend more time on an area of Christian growth and practise than is usually afforded in a Bible study.
- b) To move beyond the <u>"pat answers"</u> to areas of concern (i.e. doubts, misconceptions, etc.) held by Christians.
- c) To deal adequately and satisfactorily in these areas of concern with the view to

putting into practise what you learn.

In regard to how much time should be spent in group discussion, twenty minutes is recommended for effective involvement by all members of the Bible Study groups.
